It was also noted that there were 15% less website visits from last year, 11% less to our mobile site. Do we want to pay to update the website?

<u>Community</u>: Terry reported we had three drives of goods that went to the Mission Center. She was taking things over after the party. She has receipts for anyone who's donated if they'd like to claim them on their taxes.

<u>Membership</u>: Heather reported that members were renewing, but that A/TP renewals were slower coming in. Heather received a list of B&Bs from the Muni, and noted there are about half of them in our association. Many of the B&Bs are in Girdwood. AirB&B not taxed to our knowledge at this point. Do we need to talk about this next year? There are 285 Air B&B rooms in Anchorage on the website, 34 of them in B&Bs.






